Entrance to the Wellspring Retreat Complex

Fellow Heartfriends,

Over the past few weeks a number of masters have addressed The Hearts Center's securing of the Wellspring Retreat complex for the Great White Brotherhood. Of particular significance have been the messages of beloved Portia and Lord Ling.

Anchoring the light of God-justice on behalf of the evolutions of the planet, **Beloved Portia** came Thursday morning, Sept 27th. As the messenger of the Karmic Board, she came to respond to a request of the Darjeeling Council through El Morya, based on forward movement on the part of The Hearts Center Council. Considering both the intent and the causal body momentums of light that we as heartfriends all bring to bear, the Karmic Board is offering a dispensation of grace, *“whereby there may be an increase in [our] abundance and the light vouchsafed to [us], so long as a certain number among the body of this Hearts Center movement stand to declare and affirm with one voice their desire to move forward with the plans to secure the property”* at the Wellspring Retreat Complex.

A Call for 100 Heartfriends to Declare Their Support!

“I, Portia, now stand before you with my sword raised, to say that if a certain hundred among you would declare and aver your support of this endeavor, then, blessed ones, we of the Karmic Board will move heaven and earth to also move away the certain obstacles and barriers that have been set before you. . .” However, for the greater plan of the Karmic Board to physically manifest, there must be a one-pointedness and bold steps taken by many heartfriends *“willing to put aside certain personal agendas. . .and the drawing forth from [our] causal bodies by God's grace, and only by God's grace, that great light that [we] have access to through the ultimate surrender of the lesser self and the garnering of the light of the greater Self through [our] work and service.”*

What will this take, what will this require...only you know in your heart what is necessary for you to fulfill the request of beloved Portia on behalf of the Karmic Board.”*

The Hearts Center council is currently formulating plans for the securing of this property, contingent upon your commitment to the Karmic Board.
