This year your gifts and stories have increased beyond telling, and our movement




is now poised for exponential growth. We are focusing on customer care, e-publishing and




- Make The Hearts Center a beneficiary to all or a portion of your IRA, a tax-free action.

Frequently Asked Questions

Q: If I die without a will, who will decide where my assets go and how?

A: Your loved ones will have no say over your estate. State law dictates what happens with it.

Q: What percentage of Americans have current wills?

A: 40%.

Q: Why do many people fail to make wills?

A: They avoid addressing their mortality, they may believe their estates are too small or they believe creating a will costs more than it does.

Q: Can I make non-cash contributions like stocks and bonds or other assets to The Hearts Center?

A: Definitely. If you have investment property that you would like to donate to the Hearts Center, we can assist you in making the contribution.

Q: What about donating real property in my will?

A: Yes. You can deed your property to The Hearts Center in your will. (For many donors it is a convenient option to deed their property before their transition, retaining the right to reside on that property or continue to use it for the same purpose, such as farming the land. When you deed your property while you are still living, you receive the immediate tax benefits as sizeable charitable deductions. Legally called “a gift of remainder interest with a retained life estate,” this document allows you to maintain your existing lifestyle while taking advantage of tax savings and boosting your retirement income.)

Q: How can I update my will if there are minor changes?

A: A codicil is a brief legal instrument used to change the terms of a will. If many changes are desired, an entirely new will can be created, revoking the old will.

Q: What are changes that may require a will update?

A: A birth or death of a family member, a divorce, a move to a different state or an increase/decrease in the size of your estate are important reasons for updating your will.
